- ✦ English proficiency: IELTS 6.5 or higher (CHRIST will issue the letter)
- ✦ Complete the application form get approval from your department HoD/Coordinator
- ✦ Demonstrate your ability to support your stay overseas through a proper financial plan.
- ✦ Satisfy host institution and country entry requirements
- ✦ Be a good ambassador for the CHRIST (Deemed to be University)
