Minutes of 5th Meeting of the Board of Studies of the School of Architecture held on Wednesday, 17th February 2021 at 11:00 am in the Conference Room — Block 1, Seminar Hall - Block 2 **CHRIST (Deemed to be University), Kengeri Campus, Bengaluru.**

In the Chair: Dr. Anitha Suseelan, Professor and Head, School of Architecture

Members Present:

All the members as per the attendance list.

Declaration of Quorum:

The Chairperson commenced the meeting by a note of welcome to all the members and invitees. Thereafter the Chairperson declared the validity of the Quorum and called the meeting to order.

Matters on the Agenda:

1. To confirm the Minutes of the previous meeting held on February, 2020

The minutes of the previous meeting of the Board of Studies were duly reviewed and approved by the board. All the recommended changes were considered and further adopted in the 2020-21 syllabus.

- M.Arch 2020-22 Revisions Restructuring of the Course Structure to 4 verticals of Studio,
 Theory, Workshop and Seminar. Restructuring of the topics as Uni1 and Unit 2 for the
 course clusters of Workshop and Seminar. This has ensured increased self study component
 and also introduced greater flexibility within units.
- B.Arch 2020 21: Syllabus updation of all courses as per the Minimum Standards of Architectural Education Regulation 2020 announced by the Council of Architecture with stress on ECBC (Energy Conservation and Building Codes).
- Suggestions regarding the integration well received: co-teaching of courses, various workshops accommodated in the courses. Interaction with other Schools (Media/French) engaged. Suggestion of including professional architects to encourage students to develop their skill has been taken well.
- Suggested changes for Architecture Minor have been effected.
- Suggestion to involve Professional Architects sharing experience in the profession to encourage students to develop their skills and sustain their inquisitiveness has been effected
- Suggestion to reduce the number of courses in due course of time has been discussed and attempted in the 2021-22 syllabus.

To consider and recommend the changes in the curriculum for B. Arch Program 2021-26 & M. Arch 2021-23.

The Curriculum Revision Process: The process for the Curriculum Revision Process was explained; that there were 7 vertical leads for B. Arch and 4 vertical leads for M. Arch; working for 1.5 months to compile the document and the revisions.

The Chair extended gratitude to the coordinators (Prof. Gurudutt and Prof. Sonal), Advisors (Prof. Vijay, Prof. Shankar, Prof. Kirti) and compilation team (Prof. Vridhi, Prof. Gayathri, Prof. Elsa, Prof. Mithun, Prof. Kirti) and all other support faculty for the Curriculum Revision undertaken.

2a. B. Arch Program 2021-26

Following changes were presented and proposed by the Chair, Dr. Anitha, for inclusion in the curriculum.



- The Curriculum revision has been undertaken through program specific subject clusters, with semester objectives stated clearly and that the course content has been revised after a critical review of the course objectives and in confirmation with the COA norms 2020.
- However, the no of Credits and Working hrs are retained as per the 2020 Norms of the COA and the University concur to the 2020-21 syllabus except for Sem IV/VI/VII/VIII [in view CBCS, removal of elective cluster from the semesters to a specific common cluster]
- Restructuring Elective Courses Basket:
 - Electives have been removed from the semester wise clustering to a common list of electives.
 - Restructuring the current structure of Elective courses of all semesters and suggested to assign it as a common catalogue such that students can choose the electives across semesters. Thus the number of credits in the semesters 4,5,6 has been reduced as follows: [a] Five electives with 3 credits; [b] Two Open electives with 3 credits
 - It was suggested in the Curriculum Development Workshop to introduce more Elective courses from the streams of humanities, literature, sociology, economics.
- The Chair and Prof. Albert presented Three Summer Internships/Program each with 2 credits.
- The vertical distribution of courses based on clusters discussed with respect to credits and components.
- Integrated teaching and learning (presented and discussed in detail by Prof. Vijay): It has been suggested to reduce the number of total courses per semester by integrating few courses and increasing the credits for the Architecture Design Studio. Suggestions on integrating teaching pedagogy for the courses. Prof. Vijay presented and discussed an initial outline for V and VI semester as per discussion in the Curriculum Development Workshop. The courses are integrated with the Architecture Design Studio, with suitable changes in the credits and contact hours. Such as, courses of Building Structures and Materials Strategies, landscape and Site Planning that can be integrated with the Architecture Design Studio undertaken in their respective semesters.
- The Chair presented consider and recommend the changes proposed in the 2020-21 B. Arch Curriculum; the Selective Revision of the Course in the B. Arch Syllabus 2020-21 Semesters 1-10 [24 courses] ARC 151, 153, 131, 133, 332, 451, 452, 431, 441, 551, 532, 651, 641, 751, 752, 741, 742, 851, 852, 832, 841, 842, 843, 1051.

The No of Hours Changes for the courses - ARC 453, 533, 651, 742, 841.

The No. of Hours and Credit Changes for courses ARC 851, 841A.

2b. Curriculum changes in M. Arch Program 2021-23:

Following changes were presented and proposed by Prof. Kirti, for inclusion in the curriculum.



- Selective revision of course content in M. Arch Syllabus for semesters I to IV for 7 courses out of 15 courses: for Design Studio and Thesis, MARC151, MARC251, MARC451, for specific Units in Seminar courses, MARC382S (Unit -1 Pre-Thesis) MARC382S (Unit -2 Urban Housing), for specific units in Workshop courses, MARC152 (Unit -1 Mobility and Networks, Computational Skills and Analysis), (Unit -2 Creative Communication); MARC252 (Unit -1 Research Methodology, Unit -2 Computational Skills and Analysis (Advanced); Traffic and Transportation Planning); MARC352 (Unit -2 Paradigms of Urbanism)
- No. of hours and course code changes for MARC181S (corrected in the detailed syllabus)
- Addition of a mandatory, 2 weeks Collaborative and interdisciplinary workshop for Design Studio I and Design Studio III (MARC151 and MARC 351) to run as an intensive Vertical Studio.

Actions: After due review & consideration for above suggestions to be incorporated in Syllabus, awaiting the approval.

- 3. To ratify the changes in B. ARCH and M. ARCH Teaching, Learning and Evaluation for Theory and Practical in view of the present pandemic COVID-19.
 - The course ARC751 Practical Training (mandatory B. Arch internship) of Semester VI was revised and postponed to ARC951 for Semester IX.
 - All the courses of Semester VIII B. Arch Syllabus was advanced to Semester VII.
 - All the courses of Semester IX B. Arch Syllabus was advanced to Semester VIII.
 - The School of Architecture has undertaken Online Teaching Learning since April 2020 for all the semesters of B. Arch after due training to all the Faculty, after a dedicated Faculty Development Program. The M. Arch Program was initiated from 10th Dec 2020 in the online mode. The Chair mentioned that since February 2021, hybrid teaching and learning is being undertaken for all semesters of B. Arch and M. Arch keeping all the Covid-19 protocols in place.
 - Open Book Examination has been introduced at the Mid Semester Examination for all semesters of B.Arch.
 - A new open elective is offered from the Department of Media Studies, CHRIST (Deemed to be University); "Virtual Reality and Digital Drawing Skills in Architecture"

Actions: After due review the proposal was approved by the Board.

- 4. To consider and recommend the changes in the curriculum for B. Arch Program 2020-25, 2019-24, 2018-23 & M. ARCH Program 2020-22.
 - The summary captured in point no. 2a and 2b above.
- 5. To recommend and approve ELECTIVES, SUMMER INTERNSHIPS, Swayam/NPTEL online MOOC courses.
 - Electives have been removed from the semester clustering to a common list.
 - 3 summer internship/programs each of 2 credits: Prof Albert presented in detail, the Summer Internships/ Programs offered at three different stages of the B. Arch Program.



B. Arch VIII Semester Professional Training and Orientation Program: Prof. Gurudutt presented in brief, the orientation training given to Fourth year students on portfolio development, CV preparation, how to identify the field of interest and apply for various firms, how to follow up with firms on the application send. The present status of the student internships was also discussed that many students have got responses from the firms applied, few received confirmation and rest were awaiting confirmation. Some students are awaiting confirmation from international firms.

Action: After due review & consideration for above suggestions to be incorporated in Syllabus, the proposals were approved by the Board.

6. To consider and approve the evaluation scheme - CIA pattern and the End semester examination of School of Architecture

- The evaluation scheme continues to be comprised of CIA 50%, ESE 50% and that the Average aggregate is 45% and Semester wise aggregate is 50%.
- New Council of Architecture (COA) norms on evaluation: The two new clauses as per CoA, first clause, being that the student has to complete and pass the Architecture Design Studio for every semester to promote to the next following semester. If they fall short to get the pass grade, then the consequence will be of detention. It was suggested as a matter to be addressed immediately. Proposed to Council of Examination (CoE) of CHRIST (Deemed to be University) that an improvement / CIA Repeat can be given to the student immediately (even before the ESE theory of other courses is conducted) and also a second chance for ESE Viva Voce examination is given to the failing student, to improvise his work, grades and performance to be able to prevent a year's detention. The board discussed the alternative as a good method.
- Second clause being, Practical Training to be completed before semester X. Chair mentioned that both the clauses have to be affected. Proposed 75% attendance policy per course for consideration.

Action: Awaiting approval.

7. To consider and recommend NEW PROGRAMS - PhD Program of School of Architecture

- The Ph.D. Program at SoA is looking at two tracks, them being, Ecological Urbanism and Alternative Construction Technologies.
- One student is currently registered with School of Architecture for the PH.D. Program, under the Department of Civil Engineering.
- Fr. Benny requested for a correction, that the PhD can be under SoA going forward, after satisfying the required norms.
- Minor in Architecture curriculum for non-architecture UG students: SOA is offering
 Minor in Architecture to the UG B. Tech in 5 sets. It was offered in the current academic
 year, though the minimum number of students were not adequate to start the Program.

8. Approval of the selection criteria, admission process, etc. UG and PG program.

- No specific discussion points during meeting.
- Admission process for academic year 2020-21undertaken for B. Arch and M. Arch through online interviews through GMeet.

9. Approval of the panel of examiners and BOS Members.

• For the current BOS, the external expert, Prof. Srivatsan, is new BOS member, who is Executive Director of Centre of Architecture and Urbanism of CRDF, CEPT University.



The earlier members, Prof. Neelkanth Chhaya and Prof. Prem Chandavarkar continue in their respective roles.

• 65 examiners are identified, and the list is awaiting approval.

10. To review the Results of the ESE JUNE/JULY and October 2020 for B. Arch Program

- The result analysis of the ESE for the Odd Semester for Oct-Nov 2020 was presented for First, Second and Third year B.Arch.
- It was observed that overall performance has been good for 3B.Arch. Distinctions have increased. The number of failures in 5B.Arch has increased. There are more number of distinctions for 7B.Arch and no failures are there.
- First Semester ESE is completed and the second semester started immediately to adjust with the rest of semesters. Results are awaited for 1B. Arch.

- Labs are formed for consultancy and upskilling of the students to participate with larger spectrum and govt related projects/establishments.

22a. Suggestions for B. Arch Curriculum:

1. Ar. Prem Chandavarkar made a deep statement that for any student, the inner being should find resonance with the outer world.

He reiterated that the Curriculum in inclusive of the syllabus, pedagogy and values, that there is a difference in each. He suggested that there should be more clarity to evaluate the achievement of Vision and Mission statement across courses and their outcomes. He suggested that the pedagogical methods should be considered in writing of the syllabus so that the values of the University is imbibed in the courses for their better resolution.

He suggested that the student portfolio should be linked to the respective credits, contact hours and assessments.

He suggested to reduce the contact hours such that the lectures made by faculty may be pre-recorded and that the contact hours can be spent for more effective interactive, peer and group learning methods. He quoted approaches taken by Shristi School of Design in terms of Elective courses and suggested the idea of an Interim Semester (of 2-4 weeks) to critique and recollect the fundamentals. He lastly reiterated the importance of a social connect and context that must be integrated and imbibed with the curriculum, burning concerns of climate change, social equity and social rootedness must be included.

- Prof. Neelkanth Chhaya suggested that the kind of projects that are taken up in the design studios should think about current, social, economic and climate realities, that shall affect the teaching methods for courses.
- 3. Prof. Srivatsan suggested that the current curriculum might seem overloaded and can be changed subsequently. Total workload on a student includes face time and learning that happens outside the School. He suggested that a method to be formulated to know what is in-class contact hours and what is outside contact hours in terms of guest lectures, seminars, events and workshops. He suggested that ideally the workload along with contact hrs should be ideally 55 hrs a week.



He also suggested that 24 credits per semester, is on a higher side, and more integration among courses in teaching and learning may help reduce the total number of credits in a particular semester. He opined that the current COA norms must be treated more as a guideline, so that more explorations and experimentations can then happen with the curriculum.

22b. Suggestions for M. Arch Curriculum:

- 1. Prof. Neelkanth Chhaya opined that the start of M. Arch program is slight de-stabilisation (to the already established School and its B. Arch program) but a in a good way; he emphasized on two points as suggestion: one, being the purpose of teaching and second being, method of teaching and that the teachers themselves need to become fully equipped. Second connection or awareness of the world reality which has not sufficiently affected thinking and practise and this has to be changed, He mentioned in an institution like Christ (Deemed to be University) it is possible to happen and it rigorously energetically presumed the kind of projects set in studio should think about social realities. Suggested to inculcate an exploratory approach in students.
- 2. Prof. Srivatsan suggested that the M. Arch program needs to be more focused in its ecological component and more discussion shall be required.

General Suggestions

- 1. Prof. Neelkant Chhaya appreciated that in the last few years the School has become a little more self-aware and thinking in its territory and wished good luck for the future.
- 2. Ar. Prem Chandavarkar, with reference to the Strategic Plan's proposal of Faculty of Integrated Design, he opined that the current programs of the B. Arch and M. Arch needs to be stabilized for a period of 2 years, before venturing further ahead.
- Prof. Srivatsan suggested that the future plans of the institute depend on the kind of resources available, thus resource planning to be planned, consider financial components and prepare faculty development plans.
- 4. Student representative Eishitha Iyer thanked the School for giving the insights on the structure of the syllabus and courses offered.
- 5. Dr. Fr. Benny appreciated the overall performance of the School of Architecture in 2020-21 and yhanked the experts and emphasised on inculcating the research culture among faculty.
- 6. Prof. Raghunandan, HOD of Department of Civil Engineering and internal member of the BOS, enquired on the possibility of testing material quality and characteristics, suggested the inclusion of sustainable development in order to attain the Sustainable Development Goals.


Prof. Kirti Patnaik proposed the Vote of Thanks.

UNDERGRADUATE PROGRAMME BACHELOR OF ARCHITECTURE

The Bachelor's Degree Program in Architecture, affiliated to the Christ University, is a five-year program approved by the Council of Architecture New Delhi and AICTE. The Programme has two components, Studio and Theory. Theory encompasses the current theoretical positions on Architecture, understanding historical precedents of built environment in India and across the world, building sciences and technology. Studio courses address the issues of methods in documentation, analysis and interpretations and design process of physical environments. The studio cycle is aimed at developing design language, tools and skills to design sustainable built environments. The programme entails Practical training of one year with a registered practising architect. The Programme thus intends to render a holistic understanding of Architecture.

A. ADMISSION

Admission is open to the Bachelor of Architecture to all the candidates who have passed the Qualifying Examination of

an examination at the end of the 10+2 scheme of examination of Central/State Govts with at least 50% aggregate marks in Physics, Chemistry and Mathematics and also 50% marks in aggregate of the 10+2 level examination or passed 10+3 Diploma Examination with mathematics as compulsory subject with at least 50% marks in aggregate.

And have passed the Aptitude Test with a qualified NATA score for the aptitude test conducted by the Council of Architecture OR Qualified JEE Mains Paper II Aptitude test in Architecture

B. DURATION

The Architecture course shall be of minimum duration of 5 years or 10 semesters of approximately 16 working weeks each inclusive of six months or one semester of approximately 16 working weeks of Practical training after the first stage in a professional office. (As per COA 2017 Rules)

C. ASSESSMENT PATTERN

The assessment pattern comprises of two components; the Continuous Internal Assessment (CIA) and the End Semester Examination (ESE). The weightage of marks for subjects having both CIA marks as well as ESE marks have the ratio of 50:50. The courses are classified into two types – Studio Courses and Theory Courses.

- a. CREDIT STRUCTURE As referred in the detailed syllabus
- b. CONTINUOUS INTERNAL ASSESSMENT (CIA): 50%
 - The students shall be continuously assessed towards their CIA which comprises of creative and innovative assignments. The CIA shall have four components of CIA 1, CIA 2, CIA 3 and Attendance (Refer Table 1 and Table 2)



- 2. CIA 1, 2 and 3 for Studio courses and CIA 1 and 3 for Theory courses shall be conducted by the respective faculty in the form of different types of assignments. Students need to complete the assignments within the stipulated time for award of marks.
- 3. CIA 2 for Theory courses shall be conducted in the form of Mid Semester Examination.
- 4. A minimum of 50% in CIA is required to appear for the End Semester Examination (ESE) of a particular course

- 3. The Theory courses shall have a written exam of three-hour duration. The Studio courses shall have a Viva Voce evaluated by an external examiner and internal examiner of the portfolio presentation.
- 4. An examiner for any of the subjects of examination shall have a minimum of 3 years teaching/professional experience in his/her field of study.


I. PASS CRITERIA





Minutes of 4th Meeting of the Board of Studies of the School of Architecture held on Wednesday, 12th February 2020 at 11:30am in the Conference Room – Block 1,

CHRIST (Deemed to be University), Kengeri Campus, Bengaluru.

In the Chair: Dr. Anitha Suseelan, Professor and Head, School of Architecture

Members Present:

All the members as per the attendance list.

Declaration of Quorum:

The Chairperson commenced the meeting with a silent prayer followed by a note of welcome to all the members and invitees. Thereafter the Chairperson declared the validity of the Quorum and called the meeting to order.

Matters on the Agenda:

1. To confirm the Minutes of the previous meeting held on 06 February, 2019

The minutes of the previous meeting of the Board of Studies were duly reviewed and approved by the board. It was noted that there were no matters arising out of the minutes.

2. To consider and recommend changes in the curriculum for B Arch programme 2020-21

Following changes were proposed for inclusion in the curriculum.

B.Arch (5 Years Course) – 2019-20 Syllabus

- 1. The following courses have curriculum revision ARC131, 132, 232.
- 2. Reviewed and introduced the following courses for Semester 3 & 4 in the syllabus ARC351, 352, 353, 331, 332, 333, 334, b451, 452, 453, 454, 431, 432, 441.
- 3. Further it was brought to notice to the panel that the curriculum of all other courses shall remain the same as structured in 2019-20 syllabus as approved in the last BOS Feb 2019.

B.Arch (5 Years Course) – 2018-19 Syllabus

- 4. The following courses have curriculum revision ARC531, 532, 534, 633, 634, 751, 853, and 831.
- 5. The nomenclature have been changed for the following courses ARC534, 853.
- 6. The following courses have been changed for the number of hours in the curriculum ARC651, 652, 632, 851, and 843.
- 7. The credits for the following courses have been changed in the curriculum ARC652, 851.
- 8. The course ARC841 Elective III has been converted from Studio Course Category to Practical Course Category.
- 9. The course ARC842 has been removed from the curriculum.
- 10. The course code of ARC843 has been changed to ARC842 in the curriculum.
- 11. Further it was brought to notice to the panel that the curriculum of all other courses shall remain the same as structured in 2018-19 syllabus as approved in the last BOS Feb 2019 and is applicable for the current batches of 2017 and 2018.

Action: After due review the proposals were approved by the Board.

3. To consider and approve the evaluation scheme - CIA pattern and the End semester examination of School of Architecture

1. The board discussed and approved the eligibility criteria to appear for ESE for UG (as approved in BOS Feb 2019) and same applied for PG programs.

Actions: After due review the proposal was approved by the Board.

2. It was proposed to have a minimum of 75% in attendance for each course as a criteria for appearing in the End Semester Examinations and the request was forwarded to the Controller of Examinations and awaiting approval for the same.

Actions: Awaiting Approval

- 4. To Consider and Recommend New Programs PG Programme curriculum for M Arch programme 2020-21; MINOR PROGRAMME curriculum for Architecture Minor 2020-21 (offered to School of Engg. and Tech.)
 - M.Arch Curriculum discussion With a brief introduction by Dr. Anitha Suseelan and detailed description of curriculum was given by Prof. Kirti Patnaik. The following suggestions were given for further revision.
 - 1. Ar. Prem Chandavarkar raised a concern in the M.Arch Curriculum that the Electives are given only 2 credits out of 25 credits across each semester. It was suggested to restructure M.Arch Syllabus to provide more clarity and the course to be structured to have lesser credits.
 - 2. The syllabus needs to be built around Design Studio with Workshops, Seminar courses and Electives
 - 3. Prof. Neelkant Chhaya opined to increase the self-study component in M.Arch Curriculum thereby enhancing independent working abilities of the student.
 - Architecture Minor 2020-21 curriculum discussion —It was proposed to offer Minor in Architecture (of 22 Credits) across 5 semesters through 5 courses including 6 week internship.
 - 1. It was suggested that the credits for minors programme shall be of maximum 20 credits.
 - 2. It was suggested to follow the total number of hours as per other Minors in other departments. Time Scheduling may be done in concurrence.
 - 3. It was suggested that Readings in Architecture can be included to reduce the number of contact hours for the students.

Action: After due review & consideration for above suggestions to be incorporated in Syllabus, the proposals were approved by the Board.

5. Approval of the selection criteria, admission process, etc. UG, PG program.

The board discussed and approved the selection criteria, admission process etc. for both UG (as approved during BOS Feb 2019) and PG programs.

Action: After due review the proposals were approved by the Board.

6. Approval of the panel of examiners.

The board discussed and approved the panel of examiners.

Action: After due review the proposals were approved by the Board.

7. To review the Results of the ESE October 2018 for B.Arch Programme.

The result analysis of the ESE for the Odd Semester for Oct-Nov 2019 was presented for First, Second and Third year B.Arch.

- 1. It was observed that failure rate is increasing as progressing through the semesters.
- 2. It was suggested to have lecture series at least 6 to 8 lectures per semester and to involve Professional Architects sharing experience in the profession to encourage students to develop their skills and sustain their inquisitiveness.

8. To review Research, teaching and extension activities.

The next generation Teacher is beyond the confines of mere teaching He/she sets/adds value to their teaching career through their research, practice, social and environmental outreach initiatives.

- 1. ANSH School of Architecture Student Association which takes initiatives in conducting Fests, Studio on Wheels and Workshops.
- 2. Students of 5.B Arch have attended Social Outreach National Workshop & won Project Award organized by TERI.
- 3. Rural Studio 2019-20 being compiled for an International Competition.

11. To review Value added programs for quality standard of students.

- 1. Rural Studio Skill Development Workshop were presented as a Value Added Program being conducted at School of Architecture.
- 2. It was proposed to engage additional Adjunct/visiting faculties as per the norms of COA and can take up about 30% of the course.
- 3. It was proposed to bring in collaborative studies for the students.
- 4. It was suggested that Credits can be allotted for the subject content taken up by the Visiting Faculty.

5. It was suggested that collaboration of School of Humanities and School of Architecture for M.Arch can be achieved by providing 2-day continuous workshop which can be conducted in either campuses or any other ideal location.

Action: After due review the proposals were approved by the Board.

Suggestions for B.Arch Curriculum:

- 1. Prof. Neelkant Chhaya suggested that the number of courses may be reduced in due course of time
- 2. Ar. Prem Chandavarkar suggested that there should be a more clarity to evaluate the achievement of Vision and Mission statement across course outcomes. And also the Pedagogical methods shall be considered in writing along with the Syllabus so that the Value of the course in the University can be better understood.
- 3. Ar. Prem Chandavarkar appreciated the collaborative efforts of Department of Civil Engineering and School of Architecture in enhancing the quality of education.

Suggestions for M.Arch Curriculum:

- 1. Prof. Neelkant Chhaya appreciated the intent of M.Arch curriculum to be built around Electives.
- 2. Prof. Neelkant Chhaya gave opinion for M.Arch curriculum that it needs to be oriented towards the independent working abilities of the student.
- 3. Prof. Neelkant Chhaya gave opinion that the pedagogical methods for M.Arch needs to enhance with support of Workshops and with proper mapping of resources.
- 4. Dr. Fr. Benny Thomas also suggested reduction of number of courses in M.Arch Curriculum and to encourage self-learning modules.

General Suggestions

- 1. Prof. Neelkant Chhaya suggested for enhancing quality of teachers through Workshops on pedagogy and to understand how Pedagogy can correlate with the curriculum.
- 2. Ar. Prem Chandavarkar suggested to introduce students to Practicing Architects through Lecture Series or Workshops to enable students' interest towards the course.
- 3. Invitee Prof. Rashmi Sawhney, Associate Professor commented that they are looking forward towards the collaboration of School of Humanities with School of Architecture.
- 4. Dr. Fr. Benny appreciated overall performance of School of Architecture in 2019-20.
