Minutes of the 12<sup>th</sup> Meeting of the Board of Studies of Commerce held on Saturday, 08 February 2020 at 9.30 am at the Meeting Room, Block I, CHRIST (Deemed to be University), Bangalore Central Campus

#### Members Present

All the members as per the attendance list were present.

#### Leave of Absence

There was no leave of absence.

#### Declaration of Quorum and Calling the Meeting to Order

The Chairperson declared the validity of the quorum and called the Meeting to Order.

## Matters on the Agenda

### 1. To confirm the Minutes of the previous meeting held on 2 February 2019

The minutes of the previous meeting of the Board of Studies as per Annexure A to the Notice was duly reviewed and approved by the board. It was noted that there were no matters arising out of the minutes.

#### 2. To consider and recommend the change in curriculum for English Programme.

The proposed communication based syllabus was approved by the external examiners. A few questions regarding assessment strategies were asked with regards to class strength and number of assignments. The reasons presented were that the syllabus would result in a textbook which would carry worksheets that would be uniformly designed for all classes along with slight variations for each stream in order to cater to different requirements of the learners. suggestions for peer evaluation were also given by the members.

# To consider and recommend the change in curriculum for the Additional English Programme.

The first year syllabus was ratified and the new papers proposed for the second year course were tabled. It was decided to give two or three choices for students of one programme (BA/B.Sc/ B.Com) and rotate the papers in the fourth semester. The external members suggested that the courses should be pitched at an introductory level as there were theoretical papers. Also texts to be discussed in class should be mentioned in the syllabus along with the concepts. They also recommended inclusion of folk and oral literature and representations from literature of the North East.

# 4. To consider and recommend the change in curriculum for English Studies Programme -

The following texts were added to the existing syllabi in place of *Home and The World* by Ravindranath Tagore. One of these texts will be selected from these added texts. The changes were approved by the external examiners.

#### Postcolonial Literatures, EST531:

- · Doris Lessing Grass is Singing
- · Michael Ondaatje Running in the family
- · Naipaul House for Mr Biswas or Miguel Street
- Jamaica Kincaid Lucy or A Small Place

In place of the poems We have our Genealogies, Jean Arsanayagam and New Poetry, David Dabydeen the following poems were suggested and approved:

- · Nourbese Philip Zong
- · Derek Walcott The Sea is History

#### Indian Literatures: Themes and Concerns, EST532

- Instead of Amrtya Sen Western Imagination and Indian Tradition the following essays were suggested and approved:
- "The ghosts of Mrs Gandhi", Amitav Ghosh, Excerpts from "The Argumentative Indian", Amartya Sen, "Blood", Urvashi Butalia

The existing syllabi for the courses: British Literature, American Literatures, Literary Theory, World Literatures and Elective courses were ratified.

# 5. To consider and recommend the change in curriculum for MA in English with Communication Programme

- 7 new courses introduced in MA were tabled for the BOS.
  - Semester I Mass Communication Introduction to Mass Communication & Journalistic Writing; Semester IV - 2 Electives - Bhakti Poetry, Material Culture and Cultural Politics of Food in India
  - 4 Value-added courses across the semesters 1 per semester, Speech and Accent, English Studies for Professional Eligibility Tests, Technical Writing, Social Innovation and Entrepreneurship
- The Board recommended reviewing some of the courses like-
  - Bhakti Poetry as its outcomes were very basic and some crucial ideas were missing
    the organizing logic, recovering the past, caste and gender politics and North-East
    representation
  - Material Culture and Cultural Politics of Food in India to give ample focus on Material culture and include writings on Food.
  - The Board proposed some variety in terms of electives and courses like Folk Literature, North-East Studies, Digital Humanities, Critical Health Humanities, Caribbean Literature, African Literature, Canadian Literature etc.

- With regard to the existing syllabus a few changes were ratified pertaining to substitution and addition of new texts
  - British Literature I: Critical Readings (MEL 131), American Literature: Voices from the Nation (MEL 132), British Literature II: Multicultural Readings (MEL 231), Media Criticism (MEL 235), Postcolonial Literatures (MEL 332), Indian Literatures in English (MEL 431), World Literatures (MEL 432), Film Studies: Perspectives (MEL 433)
- Board ratified the change in the Dissertation course to Research and Publication in the 4th semester
  - Students to choose between writing a Research Paper or a Dissertation or a Project in Semester IV leading to publication
  - · Faculty to float topics or areas of interest and students to choose accordingly
  - Attendance will not be administered for the course students to work during their free hours in consultation with their guide
  - Board recommended publication as an important criteria and therefore the need to float the topics by the end of the 2nd semester itself.
- 6. To consider and recommend the change in curriculum for Qualitative Method for PhD in English Studies

Syllabi for PhD course work titled Introduction to Research Methods in English Studies was presented and approved by the board
