- 6. Candidates may prepare their travel plan as per the "Important Dates Section" and book the travel tickets well in advance in order to avoid disappointment in losing an opportunity to appear in the selection process.
- 7. Candidates failing to appear for the selection process at the stipulated date and time will be considered as "Not Selected".
