#### DAY - 2


- Miss Merin Thomas started the session with warm welcome once again, which was carried by Shashwat Seth by giving an overview of the previous session.

- Miss Sweta Nandi closed the ceremony with a vote of thanks and applauded the guest speaker for her immense efforts.


#### Outcomes:
